

RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT

This Agreement, made as of this ____ day of _____ 2013 between Pine Meadow Farm, Inc., The Bridget Twinning Memorial Foundation, Inc., Cathy Tindall, and all volunteers for the Bridget Twinning Memorial Event (hereinafter referred to collectively as "BT Ride") and the person(s) executing this document (hereinafter referred to as "Rider").

In consideration for BT Ride's services, and privilege to be on the property, Rider voluntarily agrees to the terms of this RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT and hereby agrees to personally assume the risks associated with horse riding, competing, volunteering, being around, near and on horses;

Rider hereby releases, waives, and forever discharges BT Ride of all actions of whatever kind or nature either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, or property damage - including damage to Rider's horse and other personal property - resulting during Rider's presence on BT Ride's premises and any activity involving BT Ride's services so long as such injury, property damage, or death is not caused by an intentional, willful, or wanton act or omission of BT Ride (*i.e.* Rider releases BT Ride from liability for damages caused by BT Ride's negligence only). Rider assumes full responsibility for the risk of bodily injury, death, or property damage from such activities, and shall hold BT Ride harmless for any liability thereof as set forth herein.

Rider further agrees that if a claim or lawsuit is made against BT Ride, its owners, instructors, volunteers, agents, and/or employees for any injury or damage brought by, or allegedly attributable to, Rider arising from Rider's presence on BT Ride's premises or any activity involving BT Ride's services, Rider will pay all attorney's fees and costs reasonably incurred by BT Ride to defend that claim or lawsuit and will reimburse BT Ride for any judgment, expense, or other damage incurred. Rider represents that his or horse is healthy and has a current negative coggins.

This release is given on behalf of Rider, Rider's spouse, Rider's legal representatives, administrators, executors, heirs, and assigns, and in the case of any child or children of Rider's, on behalf of them, their legal representatives, administrators, executors, heirs and assigns. This release is an ongoing release and remains in effect until Rider has revoked it in writing.

RIDER ACKNOWLEDGES AND AFFIRMS THAT HE/SHE HAS CAREFULLY READ THE CONTENTS OF THIS DOCUMENT, UNDERSTANDS ITS MEANING, AND HAS VOLUNTARILY EXECUTED THE SAME.
